

## **YOU HAVE A VOICE IN AIR POLLUTION CONTROL IN ARIZONA**

The Arizona Department of Environmental Quality (ADEQ) proposes to issue Air Quality Control Registration Number 64376 to City of Flagstaff, Utilities Division for the continued operation of a waste water treatment facility located at 2800 El Paso Flagstaff Road, Flagstaff, Coconino County, Arizona. The mailing address for the facility is 211 West Aspen, Flagstaff, AZ 86001. The facility is subject to the requirements of the Federal Clean Air Act, Code of Federal Regulations, Arizona Revised Statute 49-426, and the Arizona Administrative Code, Title 18, Chapter 2. The facility emits the following air contaminants: particulate matter, oxides of nitrogen, carbon monoxide, sulfur dioxide, and volatile organic compounds.

This public notice provides information to help you participate in the decision-making process. You have an opportunity to submit written comments on this Registration and request that ADEQ hold a public hearing on the Registration. The written comment shall include the name, mailing address, signature of commenter and/or their agent or attorney and shall clearly set forth reasons why the Registration should or should not be issued. Grounds for comment are limited to whether the Registration meets the criteria for issuance spelled out in the state air pollution control laws or rules.

The draft Registration and related documentation are available for review Monday through Friday between 8:30 a.m. and 4:30 p.m., at the [ADEQ Records Center](#), at 1110 West Washington Street, Phoenix, Arizona. The documents are also available at City of Flagstaff, City Clerks' Office at 211 West Aspen Avenue in Flagstaff, AZ 86001. The public notice period is in effect from August 24, 2016 to September 22, 2016. Comments must be received by September 22, 2016.

ADEQ will consider all comments received in making a final decision on the proposed Registration. Everyone commenting will receive notification of the final decision. People who file comments on the Registration will have the right to appeal the final decision as an appealable agency action to the Office of Administrative Hearing (OAH) pursuant to §41.1092.03, and the appeal must be filed within thirty (30) days after the issuance of the final decision. The OAH may sustain, modify, or reverse the final decision.
