8. Report on Activity of Orphaned Well Program Contractors - Chris Schmidt:

- a. <u>Orphaned Well</u>: Orphaned wells are oil and gas wells that are not plugged, not producing, and have no owner or responsible party, so they are wards of the State or other government entities.
- b. Contractors are finishing up work on Task 1: Site Assessment, submitting final Environmental Data Report (EDR) deliverables.
- c. Task 2: Site Characterization proposals have been submitted and are under review.
- d. Ground Water Protection Council (GWPC), a national nonprofit association, continues to develop the Arizona Oil & Gas Risk Based Data Management System (RBDMS) database. Database development is currently in the first phase of testing.
- e. University of Arizona continues to prepare the well data for incorporation into the RBDMS database.
