5. Treatment systems that have an "Approval Certificate" may contain additional treatment performance standards and addition design or installation constraints. The designer shall conform to requirements in rule and those in the approval certificate.
6. Systems NOT in this listing cannot be considered for installation in the Notice of Intent for an on-site wastewater treatment system.
