

**NOTICE OF 30-DAY COMMENT PERIOD
AIRGAS/AIR LIQUIDE PHOENIX FILL PLANT
WATER QUALITY ASSURANCE REVOLVING FUND
NO FURTHER ACTION DETERMINATION**

The Arizona Department of Environmental Quality (ADEQ), has received a request from Airgas/Air Liquide Phoenix Fill Plant for a determination of No Further Action (NFA), pursuant to Arizona Revised Statute (A.R.S.) §49-287.01. The request is for soil contamination at real property located at 301 S. 45th Ave., Phoenix (the site) in an area known as the West Van Buren Water Quality Assurance Revolving Fund (WQARF) area.

A determination of NFA means that ADEQ will not proceed with or require further remedial action at the site for the specific hazardous substances covered by the request, except in limited circumstances described in A.R.S. §49-287.01(G).
