- 1. A quorum is established. Ms. Laura Malone, Executive Director of the Commission noted a quorum of voting members participating virtually and in person. Ten members present and two absent.
- 2. Ms. Malone called the meeting to order at 1:36 p.m.
- 3. Welcome and Introductions/Review of Minutes
 - Ms. Malone welcomed members and attendees.
 - Ms. Malone went over virtual housekeeping for attendees.

Ms. Malone requested Commissioners review the minutes for the September 18, 2021 meeting and then called for a motion to accept the minutes.

Allen Clark offered the motion, seconded by Josh Henson.

Ms. Malone announced the retirement of Mr. Scott Omer from Deputy Director for the Arizona Department of Transportation (ADOT) and thanked him for his service on the Commission.

5. ADEQ Community Liaison Presentation

Mannie Bowler presented on the ADEQ Community Liaison & Resources. Each of the team members were introduced and gave a brief overview of their capabilities.

6. High-Hazard Flammable Trains (HHFT)

a. HHFT Report update - Ms. Malone confirmed HHFT reports from UPR were disseminated to the appropriate counties on 1/5/2022 and on 1/18/2022; as well as the BNSF HHFT report on 3/15/2022.

8. CALL TO SERC MEMBERS (ACTION ITEM RESULTS - Completed)

- **a.** Action Item 1 Result- Ms. Malone informed the Commission that AZSERC staff completed this action item. SERC staff contracted the LEPC's via phone and email to offer any assistance with compliance with biennial exercise requirements.
- **b.** Action Item 2 Result Ms. Malone informed the Commission that AZSERC staff completed task of sending a calendar invitation to the SERC members for the 10/27/2021 LEPC workshop. Moving forward all members will be invited to LEPC workshops moving forward. The next LEPC workshop is tentatively scheduled for 3/23/2022.
- **c. Action Item 3 Result** Ms. Malone informed the Commission that AZSERC staff emailed all Emergency Response Plan forms to the SERC.
- **d.** Action Item 4 Result Ms. Malone informed the commission options will be presented by Michele Martinez later on the agenda on how to act on those LEPCs who are not compliant with A.R.S. Title 49, Chapter 1, Article 2.
- **e. Action Item 5 Result** Ms. Malone informed the Commission AZSERC staff sent a copy of the SR 260 Northern Commodity Flow study to Commission Cain.

9. SERC's Accomplishments –

Ms. Malone presented an overview of the outreach, compliance, assistance, commodity flow studies that have been completed by SERC staff. Outreach and compliance are ongoing services provided to the LEPCs and stakeholders.

10. Local Emergency Planning Committees (LEPCs)

a. Voting Membership Applications Ratification - Voting membership applications were presented to the Commission for ratification. Laura Malone called for a motion to ratify the membership applications as presented.

Josh Henson offered the motion that was seconded by Bryce Rucker.

The motion carried 10/0/2 absent.

- b. LEPC Compliance Status Michele Martinez presented an overview of those LEPCs who are in or not in compliance with Arizona Revised Statue. Discussion held, no action taken.
- c. Graham and Greenlee County LEPC Merger

Ms. Malone called for a motion to accept the Graham and Greenlee Merger as presented. Discussion held.

Brent Cain offered the motion that was seconded by Josh Henson.

The motion carried 10/0/2 absent.

d. Emergency Response Plans (pursuant to A.R.S. §49-125) – Dave Varela presented the Emergency Response Plans that were provided interim approval for 2021.

Ms. Malone called for a motion to ratify the emergency response plans as presented.

Josh Henson offered the motion that was seconded by Geoff McCormick.

The motion carried 10/0/2 absent.

e. LEPC Bylaws – Michele Martinez presented information regarding status of recommendations made by staff to LEPCs regarding the Bylaws. Discussion held, no action taken.

11. Hazardous Materials Emergency Preparedness (HMEP)

- a. Status FY2021/FY2022 Michele Martinez informed the Commission ADEQ managed the Hazardous Materials Emergency Preparedness (HMEP) three-year grant. The performance period began on October 1, 2019 and will end on September 30, 2022. ADEQ was awarded \$948,496. The grant funding was used for hazmat training, planning, two Hazardous Materials Regional Commodity Flow Studies and the purchase of hazmat training equipment.
- b. HMEP Grant opportunity for FY 2022-2024 (10/1/2022 through 9/30/2025) Michele Martinez informed the Commission ADEQ will apply for a three-year grant for The Hazardous Materials Emergency Preparedness (HMEP) grant. Applications are due in April 2022.
- c. Regional Commodity Flow Study for Southern Arizona Update Michele Martinez provided an update to the Commission ADEQ regarding a regional Hazardous materials commodity flow study for Southern Arizona with thirteen monitoring sites that included participation from three counties and two tribes (Cochise, Pima, Santa Cruz, Pascua Yaqui Tribe and Tohono O'odham Nation.) The project began in July 2021 and will be completed in April 2022. The cost associated with this project is \$153,710 using HMEP funds. Discussion held. No action taken.

12.US EPA Region 9 Updates

- a. America's Water Infrastructure Act (AWIA) Workshop Greg Bazley informed the commission of the upcoming workshop that will explain the rules, roles and responsibilities of the SERC. A link to the workshop will be sent out to the Commissioners.
- b. LEPC Outreach Pilot Program Greg Bazley informed the Commission of the three EPA workshops to be conducted in May. They will be hosted in Coconino, Pima and Maricopa counties. Their intent is to provide outreach for the LEPCs and first responders of capabilities, trainings and assistance the EPA can offer.

13. Emergency Response Fund (ERF)

Chris Nutter provided information to the Commission regarding RY 2022 and the success of the program despite obstacles such as weather and COVID. Over 200 emails were sent out to fire departments, fire districts and police departments.

14. Tier II

Chris Nutter provided information to the Commission on the status of Tier II RY2021 (hazardous materials storage/not hazwaste), number of facilities, extremely hazardous substances (EHS) and chemicals reported. Discussed possible improvements of the site to best help our stakeholders. Cleaned up dashboard and data, as well as expanded on report builder. We are now able to view fees that are owed to the state.

Mike Foster- Tucson Medical Center Healthcare – Are Hospital Emergency Response Teams eligible to apply for funding through the grants and funds we offer to replace their hazardous response equipment? He is looking for opportunity for potential grant dollars for PPE and Decon equipment.

Ms. Malone stated she is unaware of any potential opportunities to assist a hospital with equipment through ADEQ.

Teresa Ehnert stated to reach out to the Arizona Healthcare Coalition (AZCHER).
