

# ENGINEERING REVIEW SECTION NOTICE OF TRANSFER 4.01 GP – SEWAGE COLLECTION SYSTEM

## INSTRUCTIONS

This form allows for the transfer of either a Constructions Authorization or a Discharge Authorization of a Type 4.01 General Aquifer Protection Permit, in accordance with Arizona Administrative Code R18-9-A304. The permittee shall provide this notice to ADEQ or to the appropriate County delegated agency that has been authorized by the Director to administer Type 4.01 General Permits, by certified mail within 15 days after the date that ownership changes. A new Notice of Intent to Discharge may be required if the volume or characteristics of the discharge have changed.

### FACILITY NAME

The facility name should be the same as the original Notice of Intent to Discharge for the authorization being transferred.

#### PERMITTEE

The Permittee is the applicant identified in the Notice of Intent to Discharge. If the authorization/permit has been previously transferred, the Permittee is the person who currently holds the authorization/permit.

### TRANSFEREE

The Transferee is the person to whom the permit is being transferred and will assume responsibility for the facility's compliance with the general permit conditions. In addition, the Transferee must:

- 1 Meet the definition of a "person" in accordance with R18-9-101(29) and A.R.S. 49-201 (26);
  - Be the owner and/or the operator of the facility or the property owner where the system is to be installed.
    - a. The facility owner is a person holding legal, equitable or possessory interest in the facility.
  - b. The facility operator is a person in control or having responsibility for the facility seeking the discharge authorization.
- 3 Corporations, Limited Liability Companies and Partnerships must be registered with the Arizona Corporation Commission;

### SITES WITH MULTIPLE PERMITS

One Notice of Transfer must be submitted for each permit. Sites with multiple permits must submit the applicable Notice of Transfer form with the applicable fee for each permit being transferred.
