

# INSTRUCTIONS FOR USED OIL PROCESSOR QUARTERLY REPORT

#### **INSTRUCTIONS**

#### REPORTING REQUIREMENTS

Pursuant to Arizona Revised Statues (A.R.S.) §49-802(C)(3), if your company processed used oil in Arizona during a calendar quarter, or your facility is a used oil processing facility that stored the same used oil on site for more than 35 consecutive days, you are required to submit a quarterly used oil processor report to ADEQ by the 30<sup>th</sup> day following the end of the calendar quarter to which the report applies (i.e., April 30<sup>th</sup>, July 30<sup>th</sup>, October 30<sup>th</sup>, or January 30<sup>th</sup>). A separate report form must be completed and submitted for **each** used oil processing facility. If your company **no longer** processes used oil in Arizona, please contact ADEQ.

These instructions have been developed to help you complete and submit your quarterly used oil processor facility report form(s). You may use this form, or develop your own form, so long as the information provided thereon and the order in which it appears matches that for ADEQ's form. If you complete the form by hand, please print legibly.

#### **COMPLETING THE REPORT FORM**

**Definitions:** Please refer to the following definitions to assist you with correctly reporting your used oil burning activities: In Addition to definitions in 40 Code of Federal Regulations, part 279, the following definitions apply.

**Used oil:** Includes oil that has been contaminated as a result of handling, transportation or storage.

**Off-specification used oil:** means used oil which exceeds any of the allowable levels in 40 Code of Federal Regulations section 279.11.

On-specification used oil: means used oil that is not off-specification used oil

**Report title:** Indicate the calendar year to which the report applies by entering it in the field provide. Indicate the reporting calendar quarter which the report applies by entering 1, 2, 3, or 4 in the field provided.

- Part I: Enter the facility name, address or location, city, state, zip code, telephone number, and EPA identification number
- Part II: Enter the company name mailing address, city state, zip code, and telephone number.
- **Part III:** Record the total gallons of used oil that were brought to the facility by all transporters, including your own company's vehicles, during the calendar quarter.
- **Part IV:** Record the total gallons of used oil that were generated from processing generator waste at the facility during the calendar quarter. One such example of this type of used oil is used oil that is separated from wastewater that comes from car washing facilities that was not classifies as used oil when brought to the facility.
- **Part V:** Report the total gallons of on-specification used oil processed and shipped, the total gallons of off-specification used oil shipped, and the total gallons of other type of used oil processed and shipped.
- Part VI: Enter the name of the person submitting the report including title and telephone number and signature.
