**SUBJECT: Partial Termination of Portions of ADEQ Delegation Agreement 16-128212 with Maricopa County Department of Environmental Services**

Dear Ms. Kober:

Pursuant to Section O Termination Procedures, this letter serves as the 30 day notice of ADEQ's partial termination of its delegation to Maricopa County Environmental Services Division of certain Functions and Duties in Appendix A of the Maricopa County Delegation Agreement ADEQ 16-128212.

Effective December 13, 2018, ADEQ is terminating its delegation of the functions and duties listed below for the Alma Ranchettes Co-op (AZ04-07286) and the Germann Water Users Association (AZ04-07296) public water systems in Chandler, Arizona, in Maricopa County. Specifically the functions and duties being terminated in Appendix A, Section A are:

**Item 9 Public Water Systems:**

- Approval to Construct and Approval of Construction application review,
- Construction inspection, certificate issuance or denial; and
- Related compliance and enforcement

**Item 10 Public Water Systems:**

- Monitoring and reporting compliance determination and related enforcement for delegated system;
- Conducting sanitary surveys to ensure proper operation and maintenance of water systems; and
- Related compliance and enforcement

All other provisions of Maricopa County Delegation Agreement ADEQ 16-128212 shall remain in effect. It is our intention to return oversight of these public water systems to the County once both agencies are confident that the water systems are serving potable water that is consistently and reliably below the nitrate MCL and that each water system has the capacity to maintain the system.
