Thank you for meeting with us on January 30, 2014 to discuss the issue of requiring a landowner in a "county island\" within the City of Mesa exterior boundaries to connect their home or business to the Mesa sewer system. Mesa has asked ADEQ to provide guidance as to this agency's interpretation of whether the Maricopa Association of Governments (MAG) 208 plan, as currently written, provides the specificity to meet the requirements of A.A.C. R18-9-A309(A)(5)(a)(iii) for the purposes of allowing a city to require a landowner to connect to a city sewer system if they are trying to construct a new septic system, or replace or expand an existing septic system, on a property in a county island. The answer is no.

MAG has an approved Certified Areawide Water Quality Management Plan, pursuant to Section 208 of the Federal Water Pollution Control Act and A.A.C. R18-5-302. Figure 4.21 of the MAG Plan depicts the Mesa Municipal Planning Area, which includes a number of county islands. The significance of the Mesa Municipal Planning Area is that the MAG Plan recognizes the City of Mesa may plan for, and ultimately provide, sewer service to this area. It is a planning tool, not a

rule or an ordinance. As such, this planning area map does not demonstrate any specific intent to require specific action(s) with regard to any unit of land within the planning area.

A designation of the general planning area in the MAG 208 plan does not identify any area of Maricopa County for connection to a sewage collection system, let alone a specific county island located within the external boundaries of the City of Mesa. The MAG 208 Plan (or an adopted master plan) would need to explicitly refer to a specific area, identify that area as an area where septic tanks should be connected to the sewer, and lastly, should denote the environmental issue being addressed. As currently written, the MAG 208 Plan and its municipal planning area map do not provide sufficient policy and implementation details for such a determination.
