<u>Call to Order:</u> Eboni Rhone called to order the regular meeting of the Certification Committee at 2:01PM through the virtual platform, Google Meet.

Roll Call: 6 of the 11 committee members were present. The Committee Chair, Dawn Simpson, was unable to attend and named Mike Osborne as her designated representative. Per Arizona Administrative Code Title 18, Chapter 5, Article 1, Section 103(F), the quorum was met and the meeting continued as scheduled.

General Business: No general business was discussed.

New Business:

YouTube Playlist

- Many have not heard about the YouTube Playlist yet. ADEQ to get the word out and add more wastewater related content.
- Adding timestamps to each webinar and the associated presentation would make the videos more interactable.
- Recorded webinars through private links/sign-in request/check for engagement.
- AZ Water to distribute link to ADEQ Op Cert playlist.
- Adding general training from EPA. Similar to the 2005 1-hour courses.
- EPA Drinking Water training system for ADEQ or stakeholders to use.
- Operators are limit to 10 PDHs when using the Op Cert playlist.

Eboni will follow up with the ADEQ Communication's team on features we can add to the playlist.

Succession Planning/Recruitment

- Successful hiring of operators using ADEQ's search database.
- Using EPA knowledge retention tool for training works for operator recruitment.
- TA providers to use EPA tools for system operations. Help with retaining operators.
- Survey systems for workforce development needs. Success in Nevada.
- TMF 2.0 could survey water system's needs and their succession plan.
- Knowledge retention is good. Succession planning can be problematic at times.
- Recruitment is difficult, because of a lack of knowledge of the position.
- AWWA vet initiative. Prison training as an option.
- High school/college blocked by requiring a GED for a Grade 1. Possible training to prepare high schoolers to enter the workforce or update the rule to allow 17+ to certify.
- National RWAAZ, Department of Labor, Veteran Affairs, and AWWA working on apprenticeship programs.
- RCAC and EPCOR partners with smaller system to help fill in operators.
- High schoolers can be a hard sell disinterested.

• Succession Planning - not a formal process and can be controversial. Further research is needed. Surveying systems with TMF 2.0 could be an excellent way to gage what systems need to acquire stable operators.
