to access Yavapai County Parcel # 205-14-246P (the “Site”), otherwise known as the Senator Mine adit or 570 Adit, for the purpose of conducting a geophysical survey and geotechnical drilling of the adjacent historical tailings pile.

- 2. This access will terminate 75 days from the date of this Order.
- 3. Defendants may access the Site but not interfere with the geophysical survey or geotechnical drilling.
- 4. ADEQ will return the affected areas of the Site to substantially the same condition that the site was in prior to the geophysical survey and geotechnical drilling.
- 5. ADEQ will provide to Defendants copies of any report prepared as a result of the geophysical survey and geotechnical drilling.
