20 ORDERED:

- 22 1. Defendant Sino Vantage Group, Inc. (“Sino Vantage”) shall allow the Arizona
23 Department of Environmental Quality (“ADEQ”) and its representatives, authorized
24 agents, attorneys, investigators, consultants, advisers, and contractors to access
25 Yavapai County Parcel number 205-15-246P (“the Site”) to dig a trench pit near the

prior geotechnical drilling location, conduct further geophysical drilling at the location if feasible and necessary to evaluate the site, and take samples (the “Work”);

- 2. This access will terminate 75 days from the date of this Order;
- 3. Defendant Sino Vantage may access the site but may not interfere with ADEQ’s access or Work;
- 4. ADEQ will backfill the trench after finishing the Work;
- 5. ADEQ will provide to Defendants copies of any report prepared as a result of the Work.
