The Arizona Department of Environmental Quality (ADEQ) proposes to issue Air Quality Control Permit Number 96653 to South32 Hermosa Inc. for the construction and operation of an underground zinc, silver and manganese mine located at 749 Harshaw Road, Patagonia, AZ 85624. The mailing address for the facility is 1860 E. River Road, Suite 200, Tucson, AZ 85718. The facility is subject to the requirements of the Federal Clean Air Act, Code of Federal Regulations (CFR), Arizona Revised Statutes (A.R.S.) § 49-426, and the Arizona Administrative Code (A.A.C.), Title 18, Chapter 2. The facility emits the following air contaminants: coarse particulate matter with diameters 10 micrometers or less (PM<sub>10</sub>), fine particulate matter with diameters 2.5 micrometers or less (PM<sub>2.5</sub>), volatile organic compounds (VOCs), nitrogen oxides (NO<sub>X</sub>), sulfur dioxide (SO<sub>2</sub>), carbon monoxide (CO) and hazardous air pollutants (HAPs).

In addition, ADEQ will hold a public hearing from 6:00 to 9:00 PM on February 6, 2024 at the Multi-Purpose Room at Patagonia Elementary and High School located at 200 Naugle Avenue, Patagonia, AZ 85624, where you may comment in person.

Moreover, you have an opportunity to submit written comments about this permit. To submit written comments, include your name, mailing address, signature (and/or your agent or attorney signature) and clearly explain why the permit should or should not be issued. Grounds for comment are limited to whether the permit meets the criteria for issuance spelled out in the state air pollution control laws or rules. The OAH may sustain, modify, or reverse the final decision.

This permit is subject to review by the Environmental Protection Agency (EPA) pursuant to 40 CFR 70.8 and A.A.C. R18-2-307. If EPA does not object to the issuance of this permit, you may petition to EPA within sixty (60) days after the expiration of EPA's forty-five (45)-day review period. A petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period, unless the petitioner demonstrates that it was impracticable to raise such objections within such period, or unless the grounds for such objection arose after such period.
