

PUBLIC NOTICE

TANK'S WILMOT RECYCLING AND LANDFILL FACILITY NON-MUNICIPAL SOLID WASTE LANDFILL PIMA COUNTY, ARIZONA

Pursuant to Arizona Administrative Code (AAC), Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality (ADEQ) intends to issue an Aquifer Protection Permit (APP) to The Fairfax Companies, L.L.C., for Tank's Wilmot Recycling and Landfill Facility (TWRLF) Non-Municipal Solid Waste Landfill. The WRLF Solid Waste Landfill will be located at 11505 S. Wilmot Road, Tucson, AZ 85756. **This notice commences a 30-day written public comment period from August 30, 2019 through September 30, 2019.**

This APP proposes the construction and operation of non-municipal solid waste landfill with a horizontal boundary (landfill footprint) of 50 acres and a permitted vertical height of 2774 feet above mean sea level (amsl) in the southeastern corner and 2850 feet asml at the northwestern corner of the landfill. The landfill cover system shall not exceed the height of the existing ground surrounding the horizontal boundary (landfill footprint). A baseline and routine groundwater monitoring plan has been proposed for the initial and future point of compliance groundwater monitoring wells. A gas monitoring plan has been proposed, which includes the installation of gas monitoring probes every five-hundred (500) feet around the TWRLF waste footprint boundary as landfilling progresses, and with the sampling and analysis of gas monitoring probes conducted quarterly.

ADEQ invites all interested persons to submit written comments concerning the proposed development. All written comments must be signed by the person making the comments and include his/her name and address. All comments must be submitted to ADEQ post-marked by the close of the public period on September 30, 2019. Submit your comments to:

ADEQ will review all written comments. If the Director finds sufficient degree of public interest in the facility plan application, or he finds that a hearing might clarify one or more issues involved in the facility plan approval, the Director will schedule a public hearing on this matter.
