

**NOTICE OF THE PRELIMINARY DECISION TO ISSUE  
A SIGNIFICANT AMENDMENT TO AN AQUIFER PROTECTION PERMIT**

Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a significant amendment to an Aquifer Protection Permit (APP) to the following applicant:

**Facility Name:** Palo Verde Utilities Company Campus 1 Area Recharge Facility

**Individual Aquifer Protection Permit No. , LTF:** P-105922, LTF No. 76958

**Permittee:** Global Water – Palo Verde Utilities Company, LLC

The Palo Verde Utilities Company Campus 1 Area Recharge Facility, consists of several facilities located in the City of Maricopa, Arizona, in Pinal County, over groundwater of the Pinal Active Management Area in Township 04S, Range 03E, Section 13, 14, 22, 26, and 27 of the Gila and Salt River Base Line and Meridian.

The public comment period is in effect from June 16, 2020, to July 16, 2020.
