

## PUBLIC NOTICE YOU HAVE A VOICE IN AIR POLLUTION CONTROL IN ARIZONA

The Arizona Department of Environmental Quality (ADEQ) proposes to issue Air Quality Control Renewal Permit Number 83817 to Willcox Feeds, Inc. for the continued operation of a livestock feed manufacturing facility located at 225 South Rail Road Avenue, Willcox, Cochise, AZ 85643. The mailing address for the facility is P.O. Box 220, Willcox, AZ 85644. The facility is subject to the requirements of the Federal Clean Air Act, Code of Federal Regulations, Arizona Revised Statute 49-426, and the Arizona Administrative Code, Title 18, Chapter 2. The facility emits the following air contaminants: particulate matter (PM), particulate matter with aerodynamic diameter less than 10 microns (PM<sub>10</sub>), and particulate matter with aerodynamic diameter less than 2.5 microns (PM<sub>2.5</sub>).

This public notice provides information to help you participate in the decision-making process. You have an opportunity to submit written comments on this permit and request that ADEQ hold a public hearing on the permit. The written comment shall include the name, mailing address, signature of commenter and/or their agent or attorney and shall clearly set forth reasons why the permit should or should not be issued. Grounds for comment are limited to whether the permit meets the criteria for issuance spelled out in the state air pollution control laws or rules. The public notice period is in effect from August 26, 2020 to September 24, 2020. Comments must be received by September 24, 2020.

The draft permit and related documentation are available for review Monday through Friday between 8:30 a.m. and 4:30 p.m., at the <u>ADEQ Records Center</u>, at 1110 West Washington Street, Phoenix, Arizona. Please call (602) 771-4380 or email <u>recordscenter@azdeq.gov</u> 48 hours in advance to schedule an appointment to review the file. The documents are also available at City of Willcox, City Clerks' Office at 101 S. Railroad Ave., Suite B in Willcox, AZ 85643. The draft permit and technical support document may be viewed online at <u>www.azdeq.gov</u> by accessing the Public Notices at the bottom of the webpage and searching for the date of this public notice.

ADEQ will consider all comments received in making a final decision on the proposed permit. Everyone commenting will receive notification of the final decision. People who file comments on the permit will have the right to appeal the final decision as an appealable agency action to the Office of Administrative Hearing (OAH) pursuant to §41.1092.03, and the appeal must be filed within thirty (30) days after the issuance of the final decision. The OAH may sustain, modify, or reverse the final decision.

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write or understand English and/or to those with disabilities.
