

## PROPOSED LEAKING UNDERGROUND STORAGE TANK (LUST) RELEASE CASE CLOSURE

The Arizona Department of Environmental Quality (ADEQ) is proposing closure of the following open LUST release:

Arizona regulations<sup>i</sup> allow case closure on LUST sites with groundwater contamination at levels above the Arizona Aquifer Water Quality Standards (AWQS) or Tier 1 Corrective Action Standards if it can be demonstrated that there is no exposure risk to public health and any remaining contamination is attenuating. ADEQ evaluated site specific conditions and analytical data provided for this site. Based on this review, ADEQ has determined that the case meets the regulatory requirements for closure.

All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be reviewed prior to completing the case closure process. ADEQ will consider all submitted written comments and reserves the right to respond to those comments following the public comment period. If sufficient public interest is demonstrated during the public comment period, ADEQ may announce and hold a public meeting.
