

**NOTICE OF THE PRELIMINARY DECISION TO ISSUE
A SIGNIFICANT AMENDMENT TO AN AQUIFER PROTECTION PERMIT**

Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a significant amendment to an Aquifer Protection Permit (APP) to the following applicant:

Facility Name: Green Valley Wastewater Reclamation Facility

Individual Aquifer Protection Permit No. 100629, LTF 83667

Permittee: Pima County Regional Wastewater Reclamation Department

The facility is located at 2201 North Nogales Highway, in a rural area approximately 0.75 miles east of the unincorporated Green Valley metropolitan area, Pima County, Arizona, over the groundwater of the Tucson Active Management Area in Township 17 S, Range 13 E, Section 36, SE $\frac{1}{4}$, SW $\frac{1}{4}$ of the Gila and Salt River Baseline and Meridian.

The public comment period is in effect from March 28, 2021, to April 26, 2021. Comments must be received or postmarked by April 26, 2021.

A public hearing request must include the reasons for such request.
