

**NOTICE OF THE PRELIMINARY DECISION TO ISSUE
A NEW INDIVIDUAL AQUIFER PROTECTION PERMIT**

Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a New Individual Aquifer Protection Permit (APP) to the following applicant(s):

Facility Name: Liberty Elementary School On-site Wastewater Facility

Individual Aquifer Protection Permit No. 513464, LTF 85691

Permittee: Liberty Elementary School District #25

The facility is located in Maricopa County, over the groundwater of the West Salt River Sub-basin of the Phoenix Active Management (AMA) Groundwater Basin, Section 32 of Township 1 North, Range 2 West of the Gila and Salt River Meridian.

The public comment period is in effect from April 1, 2021, to April 30, 2021. Comments must be received or postmarked by April 30, 2021.

A public hearing request must include the reasons for such request.
