

**PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)
NEW PERMIT**

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

The Arizona Department of Environmental Quality applied for a new AZPDES permit for the proposed discharge of up to 0.58 million gallons per day (mgd) of treated groundwater from the Central Tucson PFAS Project Demonstration Facility to the Santa Cruz River in the Santa Cruz River Basin in Township 14 S, Range 14 E, Section 22, in Pima County, Arizona. The Central Tucson PFAS Project Demonstration Facility is a groundwater remediation facility in Tucson, Arizona. The Arizona Department of Environmental Quality is conducting the Central Tucson PFAS Project Pilot Test at a former Tucson Water production well site (C-007A) to prove long-term efficacy of ion exchange treatment for the removal of per and polyfluoroalkyl substances (PFAS) from impact groundwater.

Persons may submit comments or request a public hearing on the proposed action in writing, to Devin McAllister, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to mcallister.devin@azdeq.gov. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write or understand English and/or to those with disabilities.
