

PUBLIC NOTICE

YOU HAVE A VOICE IN AIR POLLUTION CONTROL IN ARIZONA

The Arizona Department of Environmental Quality (ADEQ) proposes to issue Air Quality Control Renewal Permits #89300 and 89308 to McNeil Brothers, Inc. for the continued operation of portable concrete batch plants in the State of Arizona. The mailing address for the facilities is 8660 E Hartford Drive, Scottsdale AZ 85255. The facility related to Renewal Permit #89308 is located at 24004 N 107th Ave, Peoria AZ 85383. The facility related to Renewal Permit #89300 is presently out of state. The facility is subject to the requirements of the Federal Clean Air Act, Code of Federal Regulations, Arizona Revised Statute 49-426, and the Arizona Administrative Code, Title 18, Chapter 2. The facility emits the following air contaminants: Particulate matter below 10 micron size (PM₁₀), particulate matter below 2.5 micron size (PM_{2.5}), lead (Pb), and hazardous air pollutants (HAPs).

This public notice provides information to help you participate in the decision-making process. You have an opportunity to submit written comments on these permits and request that ADEQ hold a public hearing on the permits. The written comment shall include the name, mailing address, signature of commenter and/or their agent or attorney and shall clearly set forth reasons why the permits should or should not be issued. Grounds for comment are limited to whether the permits meet the criteria for issuance spelled out in the state air pollution control laws or rules. The public notice period is in effect from July 7, 2021 to August 5, 2021. Comments must be received by August 6, 2021.

The draft permits and related documentation are available for review Monday through Friday between 8:30 a.m. and 4:30 p.m., at the [ADEQ Records Center](http://www.azdeq.gov/recordscenter), at 1110 West Washington Street, Phoenix, Arizona. Please call (602) 771-4380 or email recordscenter@azdeq.gov 48 hours in advance to schedule an appointment to review the files. The draft permits and technical support documents may be viewed online at www.azdeq.gov by accessing the Public Notices at the bottom of the webpage and searching for the date of this public notice.

ADEQ will consider all comments received in making a final decision on the proposed permits. Everyone commenting will receive notification of the final decision. People who file comments on the permits will have the right to appeal the final decision as an appealable agency action to the Office of Administrative Hearing (OAH) pursuant to §41.1092.03, and the appeal must be filed within thirty (30) days after the issuance of the final decision. The OAH may sustain, modify, or reverse the final decision.

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write or understand English and/or to those with disabilities. Requests for language translation, ASL interpretation, CART captioning services or disability accommodations must be made at least 48 hours in advance by contacting the Title VI Nondiscrimination Coordinator at 602-771-2215 or Communications@azdeq.gov.
