

**PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)  
RENEWAL PERMIT**

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

City of Benson applied for a renewal AZPDES permit for the proposed discharge of up to 1.2 million gallons per day (mgd) of treated domestic wastewater from the City of Benson Wastewater Treatment Plant to an unnamed wash in the San Pedro River Basin in Township 17 S, Range 20 E, Section 3, in Cochise County, Arizona. The City of Benson Wastewater Treatment Plant is a publicly owned treatment works that receives domestic wastewater from residential, commercial, and industrial sources in Benson, AZ. Sludge is pumped to drying beds and disposed of at the Western Regional Landfill.

Persons may submit comments or request a public hearing on the proposed action in writing, to Julia A. Rowe, Arizona Department of Environmental Quality, Water Quality Division, Southern Regional Office, 400 W. Congress Street, Tucson, AZ 85701, or electronically to [rowe.julia@azdeq.gov](mailto:rowe.julia@azdeq.gov). All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write or understand English and/or to those with disabilities.
