

**PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)  
RENEWAL PERMIT**

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

ADEQ proposes to modify the City's permit to incorporate new state water quality law provisions. The modification will authorize discharges to Protected Surface Waters. The permit establishes measurable goals to assess the efficacy of control measure design and implementation.

Persons may submit comments or request a public hearing on the proposed action in writing, to Rosi Sherrill, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to [sherrill.laurie@azdeq.gov](mailto:sherrill.laurie@azdeq.gov). All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write or understand English and/or to those with disabilities.
