1. Authorization

This State Water Quality Certification (WQC) is issued by the Arizona Department of Environmental Quality (ADEQ) under the authority of § 401(a) of the Federal Clean Water Act (CWA) (33 U.S.C. § 1251 et seq.) and Arizona Revised Statutes (ARS) § 49-202.

Based on the information provided and identified in Section 3, ADEQ certifies that the proposed activities for the San Tan 320 Project will not violate applicable Surface Water Quality Standards (SWQS) in Sonoqui Wash and other ephemeral waters.

2. Description of Certified Activities

The San Tan 320 Project is a 320-acre residential subdivision located adjacent to the San Tan Regional Park in Pinal County, Arizona. The project will result in the discharge of 1.68 acres of fill material into waters of the U.S. for the construction of this residential development. Waters in the project area are ephemeral and mostly unnamed, however, Sonoqui Wash originates within the San Tan Mountains and flows adjacent to the project area.

Project activities relevant to waters include:

- Improvements to the existing Phillips Road on the northern border of the project area;
- Culverts will be installed on ephemeral wash road crossings within the project area:
- Utilities will be installed within road alignments;
- Grading and fill for building sites will occur;
- Construction of driveway crossings will occur; and
- Retention basins will be implemented.
