

**NOTICE OF THE PRELIMINARY DECISION TO ISSUE  
A SIGNIFICANT AMENDMENT TO AN INDIVIDUAL AQUIFER PROTECTION PERMIT**

Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a significant amendment to an Aquifer Protection Permit (APP) to the following applicant(s):

**Individual Aquifer Protection Permit No. 101437, LTF 95352**

**Permittee: Alpine Sanitary District**

The facility is located in Apache County, Arizona, in Township 05N, Range 30E, Section 11, Gila and Salt River Baseline and Meridian.
