

**NOTICE OF THE PRELIMINARY DECISION TO ISSUE  
A SIGNIFICANT AMENDMENT TO AN INDIVIDUAL AQUIFER PROTECTION PERMIT**

Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a significant amendment to an Aquifer Protection Permit (APP) to the following applicant(s):

**Facility Name: Cholla Power Plant**

**Individual Aquifer Protection Permit No. 100568, LTF No. 96385**

**Permittee: Arizona Public Service Company**

The facility is located in Navajo County, Arizona, in Township 18N, Ranges 19E and 20E, Multiple Sections, Gila and Salt River Baseline and Meridian.
