

**THE NOTICE OF THE PRELIMINARY DECISION TO ISSUE  
A SIGNIFICANT AMENDMENT TO AN INDIVIDUAL AQUIFER PROTECTION PERMIT**

Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a significant amendment to an Aquifer Protection Permit (APP) to the following applicant(s):

**Facility Name: Freeport-McMoRan Bagdad Mine**

**Individual Aquifer Protection Permit No. 105258, LTF 77735**

**Permittee: Freeport-McMoRan Bagdad Inc.**

The facilities are located at the Bagdad Mine near Bagdad, Yavapai County, Arizona, over the groundwater of the Burro Creek groundwater basin, in Township 14 North, Range 9 West and 10 West; and Township 15 North, Range 9 West and 10 West of the Gila and Salt River Base Line and Meridian.

The public comment period is in effect from November 15, 2022, to December 14, 2022. A public hearing request must include the reasons for such request.
