

**NOTICE OF THE PRELIMINARY DECISION TO ISSUE
A SIGNIFICANT AMENDMENT TO AN INDIVIDUAL AQUIFER PROTECTION PERMIT**

Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a significant amendment to an Aquifer Protection Permit (APP) to the following applicant:

Facility Name: Carlota Copper Project – Pinto Valley Road

Individual Aquifer Protection Permit No. 102640, LTF 91539

Permittee: Carlota Copper Company

The facility is located in Gila and Pinal Counties, Arizona, in Township 1 North, Range 13 East, Sections 25, 26, 35, 36; Township 1 North, Range 14 East, Section 31; Township 1 South, Range 13 East, Sections 1,2,12; Township 1 South, Range 14 East, Sections 6, 7 of the Gila and Salt River Base Line and Meridian.

The public comment period is in effect from March 2, 2022 to April 1, 2022. Comments must be received or postmarked by April 1, 2022.

A public hearing request must include the reasons for such request.
