Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue an Aquifer Protection Permit (APP) to the following applicant:

The facility is located in Pima County, Arizona, in Sections 10, 13, 14, 15, 22, 23, 24, 25, 27, 36 Township 18 South Range 15 East and Sections 19, 30, 31 Township 18 South Range 16 East of the Gila and Salt River Base Line and Meridian.

The public comment period is in effect from January 5, 2024, to February 23, 2024. Comments may be submitted via ADEQ Website <https://azdeq.commentinput.com/?id=A9McdgYEZ>. Comments must be received or postmarked by February 23, 2024. A public hearing request must include the reasons for such request. ADEQ will respond in writing to all comments submitted during the public comment period.
