A SIGNIFICANT AMENDMENT TO AN INDIVIDUAL AQUIFER PROTECTION PERMIT

Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a significant amendment to an Aquifer Protection Permit (APP) to the following applicant(s):

The facility is located in Pinal County, Arizona, in Township 05N, Range 09W, Section 03, Gila and Salt River Baseline and Meridian.

Comments must be received or postmarked by August 18, 2023. A public hearing request must include the reasons for such request.
