Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a significant amendment to an Aquifer Protection Permit (APP) to the following applicant:

#### Facility Name: Freeport-McMoRan Safford Mine

### Individual Aquifer Protection Permit No. 100534, LTF No. 95831

#### Permittee: Freeport-McMoRan Safford Inc.

The facility is located in Graham County, Arizona, in Section 36, Township 5 South, Range 25 East; Sections 31-33, Township 5 South, Range 27 East; Sections 1-2, 11-12, 13-14 Township 6 South, Range 25 East; Sections 27-29 and 32-36, Township 5 South, Range 26 East; Sections 1-6, 7-11, and 14, Township 6 South, Range 26 East; and Sections 3-6, 7-9, Township 6 South, Range 27 East, East of the Gila and Salt River Base Line and Meridian.

The public comment period is in effect from April 5, 2023, to May 4, 2023. A public hearing request must include the reasons for such request.
