

**NOTICE OF THE PRELIMINARY DECISION TO ISSUE  
A SIGNIFICANT AMENDMENT TO AN INDIVIDUAL AQUIFER PROTECTION PERMIT**

Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a significant amendment to an Aquifer Protection Permit (APP) to the following applicant:

**Facility Name:** Morenci Mine

**Individual Aquifer Protection Permit No. 100193, LTF No. 90007**

**Permittee:** Freeport-McMoRan Morenci Inc.

The facility is located in Greenlee County, Arizona, in all or portions of Sections 21, 22, 23, 26, 27, 28, and 32 - 35 in Township 3 South, Range 29 East; Sections 1 - 36 in Township 4 South, Range 29 East, and Sections 1 - 12 and 14 - 17 in Township 5 South, Range 29 East of the Gila and Salt River Base Line and Meridian

The public comment period is in effect from June 15, 2022, to July 14, 2022.
