

**NOTICE OF THE PRELIMINARY DECISION TO ISSUE  
A SIGNIFICANT AMENDMENT TO AN/INDIVIDUAL AQUIFER PROTECTION PERMIT**

Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a significant amendment to an Aquifer Protection Permit (APP) to the following applicant(s):

**Facility Name: Golden Vertex Moss Mine**

**Individual Aquifer Protection Permit No. 511225, LTF 89590**

**Permittee: Golden Vertex Corp**

The facility is located in Mohave County, Arizona, in Township 20 North, Range 20 West of the Gila and Salt River Baseline and Meridian.
