

**NOTICE OF THE PRELIMINARY DECISION TO ISSUE  
A NEW INDIVIDUAL AQUIFER PROTECTION PERMIT**

Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a new permit for an Aquifer Protection Permit (APP) to the following applicants: Global Water – Hassayampa Utilities Company, Inc.

**Facility Name: HUC Campus 2 Water Reclamation Facility (WRF)**

**Individual Aquifer Protection Permit No. P-513090, LTF 91988**

**Permittee: Global Water – Hassayampa Utilities Company, Inc.**

The facility is located in Maricopa County, Arizona, in Township 1N, Range 5W, Section 8, SW¼ E ½ of the Gila and Salt River Baseline and Meridian.
