

**NOTICE OF THE PRELIMINARY DECISION TO ISSUE
A SIGNIFICANT AMENDMENT TO AN INDIVIDUAL AQUIFER PROTECTION PERMIT**

Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a significant amendment to an Aquifer Protection Permit (APP) to the following applicant(s):

Facility Name: Inscription Canyon Ranch Sanitary District Wastewater Treatment Plant (WWTP)

Individual Aquifer Protection Permit No. 103119, LTF 87458

Permittee: Inscription Canyon Ranch Sanitary District

The facility is located in Yavapai County, Arizona, in Township 16N, Range 3W, Section 28, Gila and Salt River Baseline and Meridian.

The public comment period is in effect from January 14, 2025 to February 12, 2025. Comments must be received or postmarked by February 12, 2025.

A public hearing request must include the reasons for such request.
