Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a significant amendment to an Aquifer Protection Permit (APP) to the following applicant(s):

Facility Name: Kingman Correctional Facility WRF

Permittee: GEO Corrections and Detention L.L.C.

The facility is located in Mohave County, Arizona, in Township 19N, Range 18W, Section 15, Gila and Salt River Baseline and Meridian.

The public comment period is in effect from March 31, 2023, to April 29, 2023. Comments must be received or postmarked by April 29, 2023.

A public hearing request must include the reasons for such request.
