A SIGNIFICANT AMENDMENT TO AN INDIVIDUAL AQUIFER PROTECTION PERMIT

Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a significant amendment to an Aquifer Protection Permit (APP) to the following applicant(s):

Facility Name: Palm Valley Wastewater Reclamation Facility (WRF)

Individual Aquifer Protection Permit No. 100310, LTF 93045

Permittee: Liberty Utilities

The facility is located in Maricopa County, Arizona, in Township 2 N, Range 1 W, Section 33, Gila and Salt River Baseline and Meridian.

The public comment period is in effect from July 27, 2023 to August 25, 2023. A public hearing request must include the reasons for such request.
