

**NOTICE OF THE PRELIMINARY DECISION TO ISSUE  
A NEW INDIVIDUAL AQUIFER PROTECTION PERMIT**

Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a new Aquifer Protection Permit (APP) to the following applicant(s):

**Facility Name: Patagonia Lake State Park Wastewater Treatment Plant (WWTP)**

**Individual Aquifer Protection Permit No. 100624, LTF 82378**

**Permittee: Arizona State Park Board**

The facility is located in Santa Cruz County, Arizona, in Township 22S, Range 15E, Section 30, Gila and Salt River Baseline and Meridian.
