NOTICE OF THE PRELIMINARY DECISION TO ISSUE AN INDIVIDUAL AQUIFER PROTECTION PERMIT

Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a significant amendment to an Aquifer Protection Permit (APP) to the following applicant: U.S. Department of Interior – National Park Service.

Facility Name: Phantom Ranch Water Reclamation Facility (WRF)

Individual Aquifer Protection Permit No. 513236, LTF 79620

Permittee: U.S. Department of Interior – National Park Service

The facility is located in Coconino County, Arizona, in Township 31N, Range 3E, Section 5, NE ¼ SW ¼ Gila and Salt River Baseline and Meridian.

The public comment period is in effect from October 12, 2022 to November 12, 2022. Comments must be received or postmarked by November 12, 2022.

A public hearing request must include the reasons for such request.
