

**NOTICE OF THE PRELIMINARY DECISION TO ISSUE
A SIGNIFICANT AMENDMENT AQUIFER PROTECTION PERMIT**

Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a significant amendment to an Aquifer Protection Permit (APP) to the following applicant(s):

Facility Name: Picacho Water Reclamation Plant

Individual Aquifer Protection Permit No. 103890, LTF 93437

Permittee: Picacho Sewer Company

The facility is located in Pinal County, Arizona, in Township 7 South, Range 7 East, Section 4, NW ¼, SW ¼, SW ¼ and Section 9, NW ¼, NW ¼, NE ¼ Gila and Salt River Baseline and Meridian.

The public comment period is in effect from April 9, 2022, to May 8, 2022. Comments must be received or postmarked by May 8, 2022. A public hearing request must include the reasons for such request.
