A SIGNIFICANT AMENDMENT TO AN/INDIVIDUAL AQUIFER PROTECTION PERMIT**

Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a significant amendment to an Aquifer Protection Permit (APP) to the following applicant(s):

Facility Name: San Manuel Mine Site

Individual Aquifer Protection Permit No. 100421, LTF 66018

Permittee: BHP Copper, Inc.

The facility is located in Pinal County, Arizona, in Township 8S, Range 16E, Sections 22, 25, 26, 27, 33, 34, 35, 36 and Township 9S, Range 16E, Sections 2, 3, 4, 9, 10, 15, 16 of the Gila and Salt River Baseline and Meridian.
