

**NOTICE OF THE PRELIMINARY DECISION TO ISSUE
A NEW INDIVIDUAL AQUIFER PROTECTION PERMIT**

Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue an Aquifer Protection Permit (APP) to the following applicant(s):

Facility Name: Sustainable Effluent to Aquifer Project (SEAP)

Individual Aquifer Protection Permit No. 514107, LTF 96954

Permittee: Liberty Utilities (Litchfield Park Water & Sewer) Corporation

The facility is located in Maricopa County, Arizona, in Township 2N, Range 1W, Section 17, SE ¼ of the Gila and Salt River Baseline and Meridian.

The public comment period is in effect from August 3, 2023, to September 1, 2023. A public hearing request must include the reasons for such request. ADEQ will respond in writing to all comments submitted during the public comment period.
