### **A SIGNIFICANT AMENDMENT TO AN INDIVIDUAL AQUIFER PROTECTION PERMIT**

Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a Significant Amendment to an Aquifer Protection Permit (APP) to the following applicant(s):

The facility is located in Santa Cruz County located in Section 32 in Township 22S, Range 16E and in Township 23S, Range 16E; and un-surveyed Sections 3 and 4, of the Gila and Salt River Baseline and Meridian.
