Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a significant amendment to an Aquifer Protection Permit (APP) to the following applicant(s):

Facility Name: Verrado Water Reclamation Facility (WRF)

Individual Aquifer Protection Permit No. 105202, LTF 94502

Permittee: EPCOR Water Arizona, Inc.

The facility is located in Maricopa County, Arizona, in Township 2N, Range 2W, Section 31, NE ¼ SE ¼ SE ¼ of the Gila and Salt River Baseline and Meridian.

A public hearing request must include the reasons for such request.
