Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a Significant Amendment to an Aquifer Protection Permit (APP) to the following applicant(s):

The facility is located in Maricopa County Parcels, in Township 2N, Range 2W, Section 31, NE ¼ SE ¼ SE ¼; of the Gila and Salt River Baseline and Meridian.

The public comment period is in effect **from July 18, 2024 to August 16, 2024**. Comments must be received or **postmarked by August 16, 2024**.

A public hearing request must include the reasons for such request.
