Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a new Aquifer Protection Permit (APP) to the following applicant(s):

Facility Name: Wagner Wash Underground Storage Facility

Individual Aquifer Protection Permit No. 514358, LTF 100042

Permittee: City of Buckeye – Water Resources Department

The facility is located at the corner of West Beardsley Parkway and Desert Oasis Boulevard, Buckeye, Arizona 85396, Maricopa County Township 4N, Range 4W, Section 22 E 1/2, 23 W 1/2 of the Gila and Salt River Baseline and Meridian.

The public comment period is in effect from April 10, 2024, to May 8, 2024. Comments may be submitted in writing to: Kyle England, ADEQ, Groundwater Section, 1110 West Washington Street, Phoenix, AZ 85007 or via email england.kyle@azdeq.gov. Comments must be received or postmarked by May 8, 2024.

A public hearing request must include the reasons for such request.
