

**NOTICE OF THE PRELIMINARY DECISION TO ISSUE
A SIGNIFICANT AMENDMENT TO AN INDIVIDUAL AQUIFER PROTECTION PERMIT**

Pursuant to Arizona Administrative Code, Title 18, Chapter 9, Article 1, the Director of the Arizona Department of Environmental Quality intends to issue a significant amendment to an Aquifer Protection Permit (APP) to the following applicant(s):

Facility Name: City of Willcox – Wastewater Treatment Plant (WWTP)

Individual Aquifer Protection Permit No. 102778 , LTF No. 77113

Permittee: City of Willcox

The facility is located in Cochise County, Arizona, in Section 5, Township 14 S, Range 25 E, of the Gila and Salt River Baseline and Meridian.

The public comment period is in effect from December 14, 2022, to January 14, 2023. Comments must be received or postmarked by January 14, 2023.

A public hearing request must include the reasons for such request.
