Enclosed are the permit renewal application, updated equipment list, and updated emissions calculations for Hanson Aggregates, LLC Plant 22 – Prescott Permit No. 73446/Place ID No. 6913.

The following information was updated on the equipment list and in the emissions calculations:

- Two 1000-gallon gasoline tanks
 - These tanks were removed from the plant and emptied. They are waiting to be sold or sent for disposal.
- Crusher Plant 1
 - The permit correctly states that there are 11 conveyors, not 8.
 - The crusher/feeder is rated at 500 tons/hr maximum.
 - The screen is rated at 500 tons/hr maximum.
- Crusher Plant 1
 - The permit correctly states that there are 14 conveyors, not 11.
