PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES) RENEWAL PERMIT

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

Apache Junction Sewer District (AJSD) applied for a renewal AZPDES permit for the proposed discharge of up to 6.5 million gallons per day (mgd) of treated domestic wastewater from the Apache Junction Sewer District Water Reclamation Facility (AJSD WRF) to an unnamed wash, tributary to Siphon Draw in the Middle Gila River Basin in Township 1 S, Range 8 E, Section 8, in Pinal County, Arizona. The AJSD WRF is a publicly owned treatment works that receives domestic wastewater from residential and commercial sources in Apache Junction. Sludge is stabilized in anaerobic sludge lagoons, dried in sludge drying beds, and then disposed of in the municipal solid waste landfill.

Persons may submit comments or request a public hearing on the proposed action in writing, to Lesley Davidson Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to Davidson.lesley@azdeq.gov. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).
