

**PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)
RENEWAL PERMIT**

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

Alpine Sanitary District applied for a renewal AZPDES permit for the proposed discharge of up to 0.077 million gallons per day (mgd) of treated domestic wastewater from the Alpine Sanitary District Wastewater Treatment (WWT) Ponds to the San Francisco River in the Upper Gila River Basin in Township 5 N, Range 20 E, Section 11, in Apache County, Arizona. The Alpine Sanitary District WWT Ponds is a publicly owned treatment works that receives domestic wastewater from residential, commercial, and industrial sources in Alpine, AZ.

Persons may submit comments or request a public hearing on the proposed action in writing, to Rachel Heinz, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to heinz.rachel@azdeq.gov. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write or understand English and/or to those with disabilities.
